- Open to TCN* seasonal workers in agriculture, forestry and, fisheries – as well as hospitality following Seasonal Workers Directive
- Approval to hire TCNs* for seasonal work by Bulgaria's Employment Agency
- Proof of specialised knowledge, skills or professional experience relevant to sector and job
- Travel and accomodation expenses as well as health insurance covered by employer
- Evidence for stable, regular and sufficient maintenance funds

- TCN* representatives of a foreign commercial organisation registered with the Bulgarian Chamber of Commerce and Industry
- Representative certificate issued by Bulgarian Chamber of Commerce
- Proof of sufficient funds: minimum of 12 monthly minimum salaries Health insurance
- TCN must have considerable work
- experience and knowledge Additional requirements for the
- registered company and TCN* apply

Representatives of Foreign Companies

- For TCN* entrepreneurs and founders of high-tech ventures
- "Pitch deck" / business plan will need to be submitted
- TCNs* must own at least 50% of shares of the company
- Project will be assessed based on 6 criteria and a minimum of 8 points need to be gathered
- Validity period is 1 year with a possibility to extent for another 2 years if critiera are met



- Minimum salary requirement applies



- Host agreement stating location, content and duration of volunteer activities
- Confirmation of availability of funds for living at rate of one minimum Bulgarian salary for each month
- Health insurance
- Proof of housing
- Validity of duration of volunteer assignment up to a maximum of 1 year

Volunteer

- Submission of an action plan for entire period for which TCNs* aim to work as freelancers in Bulgaria
- 2 years of professional experience
- Sufficient funds to realise the action plan
- Minimum of Bulgarian language proficiency B1 (CEFR)



Open to highly-skilled TCNs* – higher education qualification (degree of at least 3 years study or shorter for IT professionals) or 5 years relevant professional experience comparable to higher education

• Gross salary of 1,5 times the average salary in Bulgaria Minimum duration of contract is 6 months



1.119 ssued in 2022 (922 new ones and 167 renewals)

> Blue Card holders were employed in the trade; automotive and motorcycle repair, construction and manufacturing sectors



Most single permits have a validity for 12 months and more (2.709 of the 2.831 in 2022) but a few single permits are also of validity between 6 months and 12 months (113 in 2022) and few have a validity between 3 months and 6 months (9 in 2022).
