# The Global Skills Partnership serving talents in the care sector (GSP Soins)

# **About the Project**

The GSP Soins project aims to establish a sustainable and innovative mobility partnership in the care sector between Belgium and Morocco, responding to labour market needs of both countries and strengthening the training and employment systems in Morocco and possibly other partner countries.

The project will help to develop an ethical model of skills enhancement and mobility in a highly demanded and regulated sector, which could be of value to other European member states interested in a similar scheme and/or a talent partnership with Morocco.

### **Research and Capacity Building**

The preparatory phase of the project will include an assessment of the legal and administrative, ethical, financial and operational feasibility of adapting the Global Skills Partnership approach to the target sector. The project team will work closely with Moroccan government partners, educational institutions and the private sector to build a participatory model for labour mobility of care workers and explore the current needs for key pharmaceutical occupational profiles in a complementary approach. Employers and employer associations in Morocco and Belgium will be extensively consulted to identify suitable vacancies and optimise job descriptions for overseas recruitment.



## **In-Country Training**

The project will proactively respond to the growing shortage of professionals in the care sector and their upskilling needs, helping to strengthen the capacities of public employment and training institutions and create a talent pool that will have better access to the national labour market and international opportunities. In Morocco, 185 Moroccan participants will be supported in their national or international career plans and receive technical, soft-skills and language training.



#### **Mobility**

At least 65 talents will be offered a work opportunity and support in relocating to Belgium. Specific training courses, logistical support and orientation will be organised to give talents access to reliable information on mobility to the EU and to assist them in successfully integrating into the country.



## **Cross-Cutting Activities**

Aiming to create a sustainable skills partnership with Morocco in the care sector, the project results, methodology and best practices will be presented to EU and partner country authorities and stakeholders through dedicated dissemination events, with the objective of informing decision-making and promoting sustainability and scalability of the model.
