Fostering capacities and cooperation on IBM among EaP training institutions

✔ Project completed

About the Project

This Action gathered together four EU Member States (Bulgaria, Hungary, Poland and Slovakia) and four Mobility Partnership (MP) countries (Armenia, Belarus, Georgia and Moldova) with the aim of fostering the role of training institutions in the formulation, implementation, monitoring and evaluation of Integrated Border Management (IBM) strategies and action plans. During the action, the participants had an opportunity to exchange good practices as well as to discuss harmonised approaches for future cooperation. Inspired by the achievements of the [EaP-SIPPAP Project](#), and capitalising on its Memorandum of Understanding - signed by ten training institutions from EaP and EU countries - the partner institutions involved in the Action reinforced coordination mechanisms among peer institutions.

This MPF project was implemented by ICMPD on behalf of the police and border guard academies of four EU Member States - Bulgaria, Hungary, Poland and Slovakia¹ - in collaboration with training institutions from four Eastern Partnership (EaP) countries - Armenia, Belarus, Georgia and Moldova².

Activities



IBM Strategic Planning

In the inception phase of this action, participants exchanged regarding the core elements of strategic management and learned about the key stages in the elaboration of an IBM strategy. The interaction also covered planning and risk assessment, as well as offered the opportunity to identify concrete areas of interest and intervention which are likely to reinforce the role of IBM training institutions in contributing to the formulation, implementation, monitoring and evaluation of IBM strategies and actions plans.

The role of IT tools in fostering knowledge transfer and information exchange

The second component of this action was focused on the role of IT tools to enable timely and efficient cross-border information exchanges and coordination between law enforcement authorities, which is essential in order to ensure a high level of security and tackle organised crime as well as other offences that require cross-border collaboration.

A regional thematic meeting was moreover organised in Minsk to discuss distance learning in IBM trainings, challenges in the use of IT tools to exchange information as well as the concept of SMART borders.



Monitoring and Evaluation of IBM strategies

Throughout the Action, partner institutions fostered knowledge-sharing on the main elements of Project Cycle Management and, in particular, on the concepts of monitoring and evaluation, whose application to IBM-related topics remains to date underdeveloped.

Moreover, a list of concrete priorities was established, including the setting up of an operational network of training institutions that would strengthen and ensure continuation of regional cooperation by adapting IBM concepts to each country's specificities and needs.
